MINUTES OF MEETING 7/29/2007

Article 1 New web site approved at

http://football29.myfantasyleague.com/2007/home /88570

Article 2 Blind bidding will start 2:00am Tuesday and end Wednesday at 9:00pm ET

Article 3 F.C.F.S. will start Wednesday 9:30pm ET

Article 4 All dropped players will be locked for 2 days for wavier processing, if no Owners submit a claim after 2 days they become free Agents and can be pick up on an F.C.F.S. basis. A season-long waiver listing will be used. One wavier pickup sends the Owner to the bottom. First week computer generated order.

Article 5 Owners will pick 3 players in their non-starters list to use as Tie-Breakers.

Article 6 Trades once accepted will generate a poll for 24 hours for all Owners to vote, 5 negative votes cancels trade. All voting Owners will be listed. All non-voting Owners are a yes vote.

Article 7 Uneven trades are allowed but, Owner must have a correct roster limit to submit a lineup.

Article 8 The pay scale changed 1st, 2nd, and 3rd will get \$140 each (Last year \$180.) The wild card team will get \$120. (Last year \$180) The extra \$160 will go to the Champion for a total of \$500. The extra \$20 will be added to the \$50 to pay for the Juds League on the web. All fines are added to the Champions total.

Article 9 After this year all league dues must be paid by August 10th or a fine of \$50 will be accessed. This is to insure that all Owners have an interest in being active for that year.

Article 10 Draft will be August 26th 2:00pm at Juds. Around 5:00pm or after the Juds draft the PCL league will join us in some food between drafts.

Article 11 All 15 rounds will be bid. This means that (round 15 players) the extra player can be bid for at any time.

For lineup problems call Lynn Siedschlag, Mike Core or Juds Bowling before game time.

LEAGUE

- Owners will be responsible for all operations of their team and have one vote in all league matters.
- Owners wanting to sell their team may do so with the approval of the JUDS League.
- Franchise fees of \$110.00 will be paid on or before August 10th.
- 4) The JUDS League will consist of 12 teams with 3 divisions, (SUPER, ROSE, and ORANGE)
- A scheduled season will consist of 14 games with each team playing Division teams twice and out of Division teams once.
- 6) On week 15 and 16 the playoffs will be played.
- 7) All teams will be realigned every year according to their ranking.
- 8) AFTER THE SUPER BOWL. All Bracket winners will draft last in their group.

FREE AGENTS AND TRANSACTIONS

- An auction draft will determine your initial roster. Owners will have \$100 fantasy dollars to bid on your 15 team roster, you must have one dollar left for your 15th player.
- 2) Number Of QB on Roster: 2-3
- 3) Number Of RB on Roster: 3-4
- 4) Number Of WR+TE on Roster: 5-6
- 5) Number Of PK on Roster: 2-3
- 6) Number Of Def on Roster: 2-3
- Trade deadline is the 11th week of the NFL season.
- Free Agent players may be selected on a FCFS basis. (\$1.00 each pickup) This fee will be waived until the first game of the season. Exceptions.

- a) Blind Bidding for HOT players will start on Tuesday morning at 1:00am and last until Wednesday night 8:00pm.
- b) All dropped players will be locked for 2 days for wavier processing, if no Owners submit a claim after 2 days they become free Agents and can be pick up on an FCFS basis.
- c) A season-long waiver listing will be used.
 One wavier pickup sends the Owner to the bottom. First week computer generated order.
- d) Trades once accepted will generate a poll for 24 hours for all Owners to vote, 5 negative votes cancels trade. All voting Owners will be listed. All non-voting Owners are a yes vote. (\$1.00 each team per trade)
- e) Uneven trades are allowed but, Owner must have a correct roster limit to submit a lineup.

THE FLEX LINEUP

- 1) Total Starters: 8
- 2) Number of Starting QBs: 1
- 3) Number of Starting RBs: 2-3
- 4) Number of Starting WR+TEs: 2-3
- 5) Number of Starting PKs: 1
- 6) Number of Starting Defs: 1
- 7) Should owners be allowed to submit players on bye as starters? No
- In accordance with the "MyFantasyLeague" program the Owners will be responsible for their lineup each week or the program will automatically use the previous week lineup.
- 9) The program will not allow illegal lineups
- All starting players must be declared before their games start or the "MyFantasyLeague" program will not accept the entry.
- 11) Roster changes cannot be made to affect games already completed.

BLIND BIDDING RULES

- 1) All Owners will receive \$100.00 in Token money for the year to bid on Free Agents.
- The Commish can give his bid(s) the same as the Owners. The Owners will bid as required by MyFantasyLeague setup.
- 3) All bids in by Wednesday 8:00pm.
- 4) Owners will have only (1) bid for each Free Agent.
- 5) Allowed bid ("I want to bid \$2.00 on this player...").
- Allowed bid ("I want to bid \$2.00 on a kicker, my choices are......").
- Not allowed bid ("I want to bid \$1.00 more than the highest bid on player....").
- 8) If more than one Owner bids on the same
- Player and the bids are equal then a tiebreaker will be used. Worst Record, Lowest YTD points, Commissioner Ruling
- 10) The Commish cannot give out bids to other Owners.

INFORMATION

- 1) Each team's starting lineup will determine your score.
- 2) Owners will pick 3 players in their nonstarters list to use as Tie-Breakers. If the score is still tied the score will remain a tie.
- 3) Tie breaking points will not be added to your total points
- Individual yards will not be awarded on Special Teams plays. Special Teams are kick-return teams only.
- On fake kicks all players become offenses players and players that score will get those points.
- Owners may challenge for errors in their scores to the Commissioner before next week's game. But remember MyfantasyLeague is the official program

and can only be over ruled by the Executive Board.

7) Executive Board = Commissioners and Deputy Commissioner.

SCORING RULES

Offense

- 1) Touchdowns <10=6pts, <40=9pts, 40+=12pts
- 2) QB= 1 point for every 25 total yards
- 3) Bonus of 3pts for 300 yards Passing
- 4) RB= 1 point for every 10 total yards
- 5) Bonus of 3pts for 100 yards Rushing or Receiving
- 6) Rec= 1 point for every 10 total yards
- 7) Bonus of 3pts for 100 yards Receiving or Rushing
- 8) 2 Pt conversion Scoring Player(s) = 2 pts
- 9) All = Interception = -2 pts
- 10) All = Fumble lost = -2 pts
- 11) PK= FG <50 = 3pts, 50+ = 5 pts, Extra point = 1 pt

Defense

- 1) All touchdowns = 6 pts
- 2) Safety = 2 pts
- 3) Fumble Recovered = 2 pts
- 4) Interception = 2 pts
- 5) QB sack = 1pts
- 6) Defense will drop 2 points for every 7 points they give up, starting with 10 points (Ending with 0 points)
- 7) Defense will drop 2 points for every 50 yards they give up, starting with 12 points (Ending with 0 points)

PAY SCALE

SUPER BOWL DIVISION BRACKET COST \$910

The pay scale changed 1st, 2nd, and 3rd will get \$140 each (Last year \$180.) The wild card team will get \$120. (Last year \$180) First round winners will receive an extra \$50. Winning the Championship is another \$310 for a total of \$500. The extra \$20 will be added to the \$50 to pay for the Juds League on the web. All fines are added to the Champions total.

ROSE BOWL DIVISION BRACKET COST \$190

The pay scale for 5TH, 6th, 7th and 8th will get \$15 each. First round winners will receive an extra \$25. The \$80 will go to the Champion for a total of \$120

ORANGE BOWL DIVISION BRACKET COST \$130

The pay scale for 9^{TH} , 10^{th} , 11^{th} and 12^{th} will get \$00 each. First round winners will receive an extra \$20. The \$50 will go to the Champion for a total of \$70.
